Official Actions Will Affect and Regulate Use of Real Property in Unincorporated Manatee County – Notice to Real Property Owners and General Public.

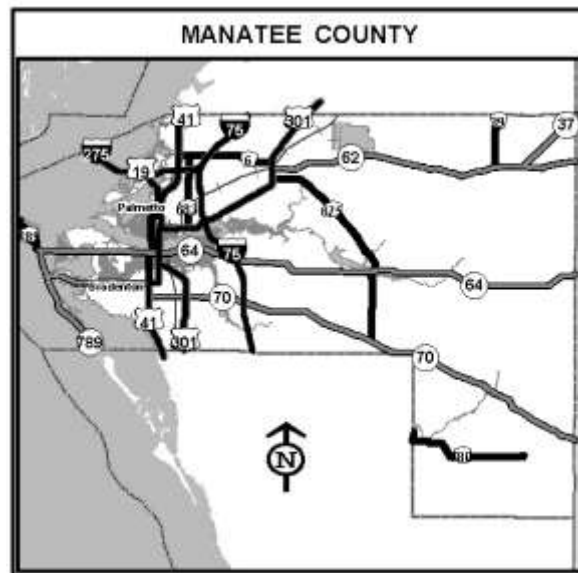

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding Comprehensive Planning, amending Manatee County Ordinance No. 89-01, as amended (the Manatee County Comprehensive Plan); providing a purpose and intent; providing findings; providing for a privately-initiated map amendment to the Future Land Use Map of the Future Land Use Element to designate 1,381.63± acres of specific real property generally located 8,650± feet east of Bournside Boulevard, north of 61st Avenue East, south of State Road 64 East, and west of CR 675, and commonly known as 21300 State Road 64 East, Bradenton (Manatee County) from AG/R (Agriculture/Rural - 1 DU/5 AC) to the UF-3 (Urban Fringe - 3 DU/AC) Future Land Use Classification; this is being required to ensure the availability of public utilities; providing for severability and providing an effective date.

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding comprehensive planning, amending Manatee County Ordinance No. 89-01, as amended (the Manatee County Comprehensive Plan); providing purpose and intent; providing findings; providing for privately-initiated text amendments and associated Traffic Map Series update to Element 5, Transportation, Traffic Sub-Element; providing for text amendments to Element 5, Transportation, Traffic Sub-Element; providing for an update of the Traffic Circulation Map Series (Map 5-B 2045 Future Traffic Circulation: Functional Classification, Map 5-C 2045 Future Traffic Circulation: Right-of-Way Protection and Reservation; Map 5-D 2045 Future Traffic Circulation: Number of Lanes, Map 5-E 2045 Future Traffic Circulation: Functional Classification and Map 5-F Future Traffic Circulation: Strategic Intermodal System (SIS) and Emerging SIS); and associated Table 5-1; amending provisions of the comprehensive plan to preserve consistency, providing for severability; and providing an effective date.

The hearing may be continued from time to time to a date and time certain. The Public may also provide written comments for the Board of County Commissioners to consider.
