The Bradenton Area Development Corporation met with <u>69</u> local companies virtually or in person, and responded to <u>45</u> qualified project leads, in addition to general inquiries and information requests, from October 1, 2019 to September 30, 2020.

Type of assistance includes:

General Assistance

- Demographics and market research The Bradenton Area Economic Development Corporation provides access to extensive demographic information about Manatee County through the GIS system on our website.
- Workforce assistance and training grants- The Bradenton Area Economic Development Corporation
 met with <u>69</u> local companies to discuss their business and workforce needs during this time. The Bradenton
 Area Economic Development Corporation connects Manatee County companies with
 state and local workforce partners, such as CareerSource Florida, CareerSource Suncoast and CareerEdge
 Funders Collaborative for hiring, internship, apprenticeship and workforce training grant opportunities.
 The Bradenton Area Economic Development Corporation collaborates with and promotes local education
 partners, such as Manatee Technical College, State College of Florida, USF-Sarasota Manatee, New College,
 UF Innovation Station, and the School District of Manatee County. The Bradenton Area Economic

 Forums and workshops – Finance/International Trade/Technology Transfer- The Bradenton Area Economic Development Corporation hosts, sponsors and promotes business forums and workshops tailored to the needs of local businesses, including (but not limited to) industry specific business roundtables, finance international trade seminars, global logistics and export readiness, lean manufacturing, marketing, CEO Forums and entrepreneurial events.

Customized Assistance:

- Site selection A real estate database is maintained on the Bradenton Area Economic Development Corporation's website. Real estate searches and site tours are conducted as requested by prospect companies.
- **Permitting and licensing** –The Bradenton Area Economic Development Corporation, in collaboration with the Manatee County Government Economic Development Official, qualified <u>21</u> new rapid response projects.
- Incentives—The Bradenton Area Economic Development Corporation provides companies with the appropriate state and/or local incentive information based on the type of project, targeted industry, job creation, projected wages, and capital investment. The Bradenton Area Economic Development Corporation collaborates with the local or state governing body to facilitate the incentive application process.
- The projected capital investment of businesses due to the assistance of the EDO. The capital investment of businesses assisted by the Bradenton Area Economic Development Corporation is projected to be <u>\$302,070,000</u> over the next three to five years.
- The projected number of new direct jobs as a result of a business being moved into the area or expanding in the area due to the assistance of the EDO. The Bradenton Area Economic Development Corporation assisted <u>14</u> companies with a combined projected job creation total of <u>582</u> jobs over the next three to five years.
- The number of these jobs retained. The Bradenton Area Economic Development Corporation assisted <u>8</u> local company expansions during this fiscal year. The existing jobs with these companies were <u>not</u> in danger of leaving the Manatee-Sarasota region.
