- Set-up begins at 3:00pm and must be completed by 5:00pm; Tear-down at 8:30pm.
- Vehicles must be parked in the vendor or general parking area by 5:00pm.
- Vendors who leave prior to 8:30pm will not be invited to attend future events.
- Food vendors are required to provide a certificate of insurance naming Manatee County as additionally insured.
